a. Henk DeJong expressed thanks expressed for the financial Support that our churches are sending. They continue to celebrate Increased Enrollment – to just over 1,00 – because of a generous donation which resulted in tuition being frozen. With the long worked for Charter Change, Redeemer can officially use University and convey up to 20 new degrees. Work continues in establishing a formal school of business and of education. The new expansion is now open and operational, the grand opening will, Lord willing, take place in the coming month(s). Financial sustainability, as always, is a challenge for Redeemer...particularly with the loss of almost \$2 million in rental revenue. The Presidential Search for Redeemer is coming to a close with an announcement coming soon.
