Finally, you will find the outcome of the survey conducted among the ministers to determine their availability and willingness to be delegated to Synod 2017 attached as well.

## ORIENTATION FOR DELEGATES

### Introduction:

Classis consists of three delegates from each member congregation – a pastor, an elder and a deacon. First-time delegates are asked to sign the *Covenant for Officebearers* at the registration desk.

*Delegate Credentials* are processed by the church council and are to be submitted by the Council, to the Stated Clerk via email prior to the classis meeting by your council clerk.

### Duration of Classis Meetings

- The meetings normally are held on Tuesdays and are held in the afternoon and evening. Start time is determined based on the length/needs of the agenda.
- Ordinarily a ministry session of some kind is held in the evening in order to allow for members of your congregation to participate.

### Classis Agenda:

- The Classis Agenda will, ordinarily, be in the hands of church councils eight weeks prior to the actual meeting date of classis. This is done to allow each church council to review the agenda prior to sending delegates.
- Delegates are to thoroughly familiarize themselves with the classis agenda. The assumption is that the agenda has been discussed at the delegates' local council meetings.

### Executive of Classis

- The Executive consists of a Chair, Vice-Chair and the Stated Clerk. A Reporter is also appointed for each meeting and serves as the Vice-Chair at the next subsequent meeting.
- The chair is elected by classis in its October meeting to serve during the following calendar year. The vice-chair is appointed by rotation and the stated clerk is elected annually at the May classis meeting.

### What May I Expect to Happen at Any One Classis Meeting?

- First time delegates are to sign the Covenant for Officebearers.
- The Classis Agenda will, ordinarily, be in the hands of church councils eight weeks prior to the actual meeting date of classis, and so delegates should have it at that time as well.
- Delegates may be requested to serve in the following capacities:
  - **Prayer:** for the ministries of classis, concerns of classis and/or for individuals.
  - **Committee work:**
  - Delegates in teams of two churches may be asked to serve on one of its advisory committees, Credentials, Ad hoc (as determined by previous Classis or Classis Interim Committee) or Overtures & Appeals. They are expected to submit their recommendations at least three weeks prior to the classis meeting.
- Though there is a degree of flexibility (especially where there is silence on a matter), classis abides by its own Rules of Procedure together with the rules of the CRCNA Church Order in conducting its meetings. The Church Order is determined by Synod and is held in covenant by all CR churches. The classis Rules of Procedure are at:

### What Are Classis' Expectations of Me?

- Be on time for all sessions of classis.
- Delegates are expected to review the agenda with their council, sharing the thoughts of their council on any particular agenda item. Delegates are not obligated to vote according to their council's wishes. Classis is a deliberative body and the freedom needs to remain for delegates to

vote on the basis of the best information or perspective presented at classis. (*Church Order*, Article 34; & *Manual of CRC Government*, Article 34, Commentary #'s 1 – 4.)

- If you do not understand the procedure, or it is not clear what is being discussed, or you are uncertain of the implications of a decision, ***please ask***. It is important that all delegates deliberate and vote with good awareness of what is going on. Classis would rather take a moment to ensure that, also for the meaningfulness of your time there, than try 'rush' through the agenda.
- You are expected to remain at classis until the meeting is formally adjourned. If there is an urgent need to leave, or if you will be replaced at some point by an alternate, delegates are to seek the permission of the chair
- Be aware that classis is a deliberative body and may make decisions from time to time that you do not necessarily agree with.
- Strong objection to a decision of classis may be voiced by stating your objection. If you wish to have your objection recorded, you will need to submit a written statement (within 24 hours) indicating your objection and reason(s) why.
- Delegates should report to their councils the decisions made at the classis meeting.

## 2. *SHALOM MANOR CHAPLAINCY COMMUNICATION*

December 13, 2016

Final Report of the Shalom Manor Chaplaincy committee re: the expanded mandate given by Classis Hamilton and Niagara in Feb of 2016.

The Proposal was that:

The Shalom Manor Chaplaincy Committee (SMCC) requests the approval of a join resolution of both Classis Hamilton and Classis Niagara at their respective meetings in February 2016. The SMCC will present a proposal, to both Classis, for a new model of governance and financial support for the Chaplaincy ministry at Shalom Manor & Gardens. This new model will, at minimum:

1. Broaden the governance of the Chaplaincy ministry to include all interested Reformed denominations and congregations residing in the Hamilton and Niagara regions;
2. Broaden the financial support to include all Reformed denominations and congregations who participate in the governance of the Chaplaincy ministry;
3. An interim report of the work of the SMCC will be made available to both Classes in time for the October 2016 meetings with final recommendations to be received in time for the February 2017 meetings.
4. We ask each classis to table and/or hold off implementation of any overtures dealing with the current funding model pending the final report of the SMCC on this matter.

In October of 2016, both Classis Hamilton and Classis Niagara passed a resolution that transferred the governance of the Chaplaincy ministry to the Board of Shalom Manor and Gardens and agreed to a 5 year funding program to continue the partnership of this vital ministry.

The Board of Shalom Manor and Gardens has now undertaken the creation of a transition team to prepare for the orderly transfer of governance and as such the long standing work of the Shalom Manor Chaplaincy Committee (SMCC) has come to an end.

SMCC now requests that Classis Hamilton and Classis Niagara release the members of the SMCC from their terms and consider their mandate complete.

1. It aligns the work and ministry of Classis with the work and ministry of the Denomination that we are a part of.
2. The mandate of the CMT includes connecting Denominational ministries with the ministry of Classis Hamilton.
3. The goals of the CRC, as put forth in the ministry plan of the CRC (“Our Journey 2020”), align with Classis’ goals of strengthening congregations and helping them thrive. “Our Journey 2020” may give direction for Classis ministries and discussions.
4. There have been many conversations, lots of thought, and plenty of work put in to create “Our Journey 2020” that we should benefit from. “Our Journey 2020” also includes resources that may prove useful.

#### 4. CHHMC REPORT

##### **Classis Hamilton Home Missions Committee**

Report to Classis  
December 8, 2016

##### **A. Church Planting Strategy Update**

The CHHMC was glad to have church planting affirmed as an essential part of our mandate in the course of our discussion at the May 2016 Classis meeting. While enthusiasm is present for planting a new church in principle, there was also a clear message that the classis is not at this time ready to proceed with a specific and ambitious plan. Essentially, in answer to our request for affirmation of church planting, what your committee heard was “Yes, but not yet.”

Elevating church planting as a value in the classis will require a significant investment of time, money, expertise and other resources. As part of a long-term strategy of preparation, the CHHMC is been building a relationship with Rev. John Bouwers and the Crosstowne church plant in Milton. Not only is Milton geographically relevant to us as on the very border of our classical boundaries, but John is well known to many of us as a recent pastor in the classis (at Meadowlands Fellowship). John is well placed to advise us on the next steps for church planting within our own boundaries.

To facilitate that relationship, building goodwill for our mutual benefit, the CHHMC has given a grant of \$3,000 to the Crosstowne church plant in 2016, and plans to do so again in 2017. This assistance is a way that we can be solidly ‘in the game’ of church planting, and is a good and fair reflection of the ‘already and not yet’ reality of our heart of reaching our neighbours through church planting in the classis.

##### **B. Church Planting Reserves**

At present the CHHMC has a church planting reserve fund of just under \$40,000. The purpose of this fund is to give a solid financial boost to a church plant as it seeks to get established with significant initial capital costs (space rental, office equipment, purchasing property, etc.). Conversations with other classes and an awareness of such costs in our area have made it apparent that this reserve fund is too small. Adding to the fund is better done slowly, over several years of preparation, rather than by presenting Classis Hamilton with a large budget request all at once.

However, in 2013, a decision was made that no further funds would be collected for the church planting reserve fund until the CHHMC had presented a clear plan of action to Classis. As we begin moving toward formulating a plan, we see clearly that the saving and investment phase cannot be delayed.

To rectify this situation, the CHHMC will be making two requests in the coming year: that the decision to halt funding of the reserve be rescinded, and a budget request in the fall for continuing to build the reserve fund.



### **C. Outreach Ministry Grants**

As part of our mandate to encourage and equip churches in their local outreach efforts, the CHHMC has funds set aside for assisting congregations. If your congregation has a missional ministry initiative that just needs some seed money to get started (advertising, food, Bible study materials, etc), we would be happy to be of help! Keep an eye out for more details and a call for proposals in the coming months.

## 6. CANADIAN MINISTRIES DIRECTOR'S REPORT



December 8, 2016

Consider this an update to you as local church leaders as to the goings-on from the perspective of the Canadian Ministries Office. It is being written just prior to Christmas so I will take a few liberties in telling you about updates with a mind to what I imagine will have happened by the time you gather, unless our Lord returns prior to that time. I will do so in bullet form as a way of saving you from an even longer Classis agenda.

- We have been busy with the pursuits of collaborative ministry efforts which are centered around the 'Our Journey 2020' ministry plan. We are engaged via a vis our agencies and ministries in efforts that bolster the work of local churches in their communities, discipleship, and leadership, all in a reformed fashion. Measurables and metrics are all part of discerning good behaviours. Ask about content for each area or let us know where your church is most passionate in the context of those Desired Futures and we would be happy to partner for ministry growth in your church.
- The effort of serving Canadian churches continues through resourcing via our [crcna.org/Canada](http://crcna.org/Canada) website as well as the directory and mostly through the ongoing progress in creating a "Customer Service" entity that has as its main thrust the serving of churches through every means possible and tracking with them not just through one agency but through all that the CRCNA and its partners offer. Next time any ministry issue comes up in your church, think about calling Servicelink in the Burlington office as a way to begin the journey toward a solution. - Through the gracious support of philanthropists within the CRCNA and much work by staff, the development, piloting and implementation of a multi-functioned app for one's phone will have been launched by the time you meet as classis. It is meant to be missional for newcomers or new believers. It is meant to be a community builder for members of your church. It is meant to provide spiritual growth content for every user. It is meant to host all your churches video content (ie. sermons). It is meant to resource leaders and also to bridge the gap between the denominational tools and the local church. And, it is meant to be a channel for fundraising and even act to foster prayer community. Look for it to come as a free option for your church VERY soon. Here is a 'still' of its opening screen:



- Our Canadian agencies have partnered together and stretched their existing budgets to experiment in a trial hire of an individual, Cindy Stover, who will be working to integrate all the areas of justice worked on in the CRCNA within Canada for the sake of engaging the local church toward greater Godly integration of justice themes into their local/regional efforts. She started December and is tying together the work of World Renew, Diaconal Ministries Canada, Centre for Public Dialogue, Office of Social Justice and others. You will likely hear from her at some point. Ask about some very new advocacy pieces that your local church small groups could easily use and you'll be impressed at how quickly your voice is heard in Ottawa with your local MP!
- In January we will have met again with the Stated Clerks and another Classis Ministry Leader for a two day meeting in Burlington to take further steps toward Classis health. You should expect your representatives to report back into Classis with the beginning of ideas and discussions around the how Classis can be reimagined to execute life changing ministry for your region and through the partnership that is the group of CRC churches in its constituency. Thank you for your partnership in this growth.
- Our aboriginal ministries continue to do wonderful work and represent the best of the Christian Reformed Church's contextualized ministry well in their respective places. Together with that, the Canadian Aboriginal Ministry Committee puts in a lion-share effort in making content and resources to churches across the country. Knowing the importance of the Truth and Reconciliation Commission, this is engaging work and very, very relevant.
- The seemingly distant Canadian National Gathering has had some interesting impact. Potential for nation-wide prayer ministry, integrating regionalized ministry approaches, affirming the ministry plan, strengthening of relationships to Mission Montreal, practices of resourcing congregations, and leadership training ideas have all come out of the Gathering and will continue to shape us as Canadian CRCs.

I look forward to speaking about these things and much more when we get together. In the meantime, let me encourage you to help your church understand the good, good story of the CRC through the lenses of the Ministry Plan videos you can find here: <https://www.crcna.org/welcome/our-journey-2020>

They are great for offering slots on Sunday, congregational meetings, small group kick-starters etc.

### **A. General Updates**

- **Increasing Denominational Diversity:** World Renew is seeing the need to increase our denominational diversity by developing a strategy to increase partnerships and revenue streams with more churches outside the Christian Reformed Church.
- **Speakers List/Workshop List:** A list of World Renew speakers and workshops will be made available on our website in 2017 in order for groups to more easily build a connection with World Renew.
- **Speaking Engagements:** Various presentations were made in Fall 2016 by the Canadian Church Relations team as we continue to make efforts to ensure World Renew's ministry is shared with churches, schools and groups across the country.
- **School Connections:** Increasing connections are being made between World Renew and various Christian schools across the country. Many schools are using resources from World Renew to learn about development and disaster response. Schools are also choosing World Renew to express their love and support for people in need, through donating to its work.

### **B. Staff Changes**

There have been many changes within the Canadian World Renew team in the Burlington office.

- **Sarah Brooks** was hired as Intern, Event and Communications for the Sea to Sea team and started in her new role in October 2016.
- **Cameron Klapwyk**, Refugee Program Associate, was hired in October 2016 to assist with the increasing volume of refugee sponsorship requests we have received.
- **Emma Cunningham**, Donor Relations Associate in BC, is on parental leave. **Cheryl Hanks** was hired to bridge the gap for Western Canada and started in November 2017.
- **Anne Varghese** of the Constituency Relations Team has stepped down from her part time role as Donor Relations Associate however, will remain in her Administrative Assistant position with World Renew.
- **Rebecca Walker**, Refugee Program Coordinator, is on leave with plans to return in early 2017.
- **Michelle Kikkert**, Digital Communications Associate, will be returning from parental leave in January 2017. We say farewell to Cameron Phillips who filled her parental leave placement.
- **Melody Mendonca**, Advocacy Manager for the Good Soil Campaign, will be finishing her role this month however, will be continuing on in a smaller capacity providing support for World Renew's diversity and anti-racism group.

- **Iryna Goy** has been hired as Administrative Assistant for the Systems Group on a part time basis and started her position this month.

### C. Upcoming Offering Dates

Here are World Renew's upcoming offering dates for the first half of 2017, as approved by Synod.

- **March 5 – Canadian Foodgrains Bank Sunday:** World Renew's total funding for food assistance, food security and conservation agriculture programs through CFGF in 2015/16 was \$9,212,797, which is about \$1.58 million more than the previous fiscal year. Offering resources will be sent to the churches in early 2017.
- **April 23 – Refugee Sunday:** The refugee sponsorship work being done churches across Canada will be both celebrated and encouraged. Thanks, churches of Classis Hamilton, for your part in this! On her half-acre farm, Jane uses many new techniques, including crop rotation, minimum tillage, and mulching her crops to preserve moisture. The thriving green maize plants taller than Jane's head are proof of how effective that has been. Her neighbours said she must have been breaking her back to carry enough water to produce a crop so green and healthy, but when she told them she was not, they could hardly believe it. Now that her neighbours see the results, they want to know more, and Jane is eager to tell them. The original group of 160 farmers who received the training through ADS-Mt. Kenya have gone on to train others, and now a total of 640 farmers have learned how conservation agriculture practices can improve their nutrition, increase yields, and enhance food security in the region.*

*The success of projects like this can be traced back to a **web of partnerships**—from the government level, to organizations like World Renew and ADS-Mt. Kenya, to field staff who deliver training programs, and the person-to-person relationships between local farmers.*

*As one of the member agencies for Canadian Foodgrains Bank (CFGF), World Renew has a key role in the Good Soil campaign, which seeks to draw attention to the need to increase support for small-scale farmers in Canada's international aid programs. As noted in the Good Soil materials, almost half the world's*

*farmers are women, but they receive only 5% of farmer education and improvement services worldwide. The effect of this training was immediate and obvious in Jane's life.*

*She noted that her family used to experience three hunger months per year, but now her farm not only produces enough to feed her family, but also a surplus that she is able to sell. With the money from those sales, Jane was able to open a small one-room "hotel," where people come to buy food or rent space to sleep. She has plans to expand her farm by adding some cows and goats, and building a fence.*

*Jane's generosity extends beyond her hospitality to a group of faith leaders from Canada and her role as a community leader, sharing the training she received with her neighbours; she also would not let World Renew Kenya Program Consultant Stephan Lutz leave without two of her beautiful sweet potatoes (freshly dug out of the ground!), and two of her chickens.*

*It has been nearly three months since I traveled to Kenya, but the memories that come back to me most often are the faces of Jane and the other farmers we visited, the warm hugs and handshakes, the smiles and generosity that were part of every visit we made. I wish I could tell Jane and so many others just how much they taught me in our short time together: how we are made to be in community, how we can share with others no matter how little we have for ourselves, how transformation happens not just from ideas but through relationships, how partnerships between the government and other agencies make possible this kind of dynamic growth and opportunity, and most of all how (as Jane said when we first came to her farm), the best things happen—and we all have the opportunity feel a little more at home, with enough food for everyone—because we are together.*

#### **D. Disaster Response: North America (DRS) and International (IDR)**

Being an integral part of the community in which we work has always been a hallmark of World Renew's activities world-wide. The approach that World Renew uses has been featured in a recent book publication, **From Aid to Trade** by Daniel Jean-Louis and Jacqueline Klammer. The book highlights World Renew's response to the 2010 Haiti earthquake, noting that World Renew purchased more than 90 percent of its relief and reconstruction efforts locally, in partnership with Haitian businesses, resulting in job creation for the community. The book contrasts this approach with other aid organizations who purchase food and materials from foreign sources, putting Haitian farmers and small businesses at risk of losing their livelihoods. World Renew has, for years, been involved in global discussions about how we honour families and communities we serve in our disaster response and development by enabling them to hold us accountable for the commitments we make to them through our programs. World Renew as a member of the Humanitarian Accountability Partnership (HAP) and a founding member of the CHS Alliance. The CHS Alliance is a group of over 200 organizations working together to hold each other accountable to the **Core Humanitarian Standards** (CHS) through self-assessments, peer review and external certification. World Renew is committed to becoming certified against these standards and is working to improve and strengthen accountability tools within the organization. A working group has been established within World Renew to give guidance to this process which will include a review of policies and procedures and strengthening of feedback and complaint mechanisms at the community level.

#### **E. Refugee Settlement Activities**

Refugee settlement statistics from January 1, 2016 to date:

- Number of applications submitted by CRCs – 113
- Number of CRC churches who have submitted sponsorship applications – 43
- Number of applications submitted by churches of other denominations, community organizations, individuals, etc. – 34
- Total number of applications submitted by both CRC and non-CRCs – 160
- Number of family members sponsored by CRCs – 315
- Number of family members sponsored by churches of other denominations, community organizations, individuals, etc. – 111
- Total number of family members sponsored by both CRC sponsors and non-CRC sponsors – 426

During the latter part of 2016, the number of applications we have submitted has continued to increase. We continue to get requests from new sponsors. Fortunately, we have been able to access additional allocation spaces to accommodate these requests as World Renew used all the initial annual allocation in mid-August. Allocations for 2017 are expected early in the New Year. Thanks very much to the five CRCs of Classis Hamilton which sponsored refugees during 2015-2016.

### F. Justice

Justice and advocacy are key parts to World Renew's work in North America and globally. So much so, that we partnered with a few other agencies and organizations to develop two publications:

### G. Sea to Sea

Registration is now open to bicyclists and volunteers on the Sea to Sea cross-continental bike tour, an athletic event that raises funds to help end extreme poverty worldwide. Registrants can sign up for the entire 9-week ride or a segment of it at [seatosea.org](http://seatosea.org). The full tour takes place from June 26 to August 31, 2017, and spans the U.S. and Canada from Vancouver to Halifax. Sea to Sea currently has 43 riders signed up, 8 volunteers registered, and \$86,000 dollars raised out of our \$3,000,000 goal. We aim to have over 200 riders on the tour, which makes recruiting our priority.

## **The purpose of Sea to Sea:**

Sea to Sea has one purpose: Cycling to end poverty. Sea to Sea is a bicycling mission fighting poverty through fundraising and awareness. Riders from around the world cycle across North America advocating for hope in the face of the poverty cycle.

Poverty is a real, immediate problem. 800 million people live in extreme poverty in the world today and nearly half of the world is living on less than \$2.50 per day. Sea to Sea is a response to global poverty—we can and should be working toward solutions. So we cycle.

### **How it works:**

Sea to Sea supports co-hosts Partners Worldwide and World Renew in their efforts to fight poverty around the world.

**Partners Worldwide** is a global Christian network that uses business as the way to end poverty. They partner with local businesses and businesspeople around the world to use four methods—mentoring, training, access to capital, and advocacy—with the mission of ending poverty.

**World Renew** envisions a world where people experience and extend Christ's compassion and live together in hope as God's community. Through microloans, community development, and savings groups, World Renew is equipping people struggling with poverty to change their stories so that more communities can achieve enough food, good health, fruitful work, and greater peace and justice.

### **How Sea to Sea can help your church's local poverty-fighting efforts:**

Since 2005, Sea to Sea has been cycling to benefit churches and nonprofits working to break the cycle of poverty. The Tour Partner program is designed to create funding for your church and the local poverty ministries you support.

Churches recruit members to participate in Sea to Sea. One important thing to mention: when recruiting people to ride, don't restrict it to known cyclists or athletes. We have seen some of the most unexpected people be called by God to help in this mission. Ask everyone!

### **Now, onto the specifics.**

Each Sea to Sea rider has a fundraising goal based on their ride length: a one-week rider has a fundraising goal of \$3k, a two-week rider has a fundraising goal of \$6k, and a full-length rider has a fundraising goal of \$12k. When your church recruits members to ride, 20% of the funds raised, up to that \$3/6/12k goal will be given to your church's local poverty-fighting ministry.

After the fundraising goal is hit, your church will receive 50% of funds raised for every dollar above the fund-raising goal.

For example, let's pretend your recruit is a full-length rider (goal of \$12k) and raises \$16k. Your church would receive 20% of the money up to the \$12k goal, or \$2.4k.

Your church receives 50% of the money after the \$12k goal. Since the rider raised \$16k, they are \$4k over goal. 50% of that is \$2k. Add the money earned at 50% to the money earned at 20% and you have a total of \$4.4k to use for your church's local poverty fighting efforts.
